LETTER FROM THE BOARD

1. INTRODUCTION

The purpose of this circular is to provide the Shareholders with information in respect of certain resolutions to be proposed at the Annual General Meeting to be held on 11 June 2026.

2. PROPOSED RE-ELECTION OF DIRECTORS

In accordance with Article 16.18 of the Articles of Association, Mr. Daniel Manwaring, Ms. Yue-Sai Kan (“**Ms. Kan**”) and Ms. Janet Yang shall retire from office as Directors at the Annual General Meeting, and, being eligible, will offer themselves for re-election at the Annual General Meeting.

In particular, Ms. Kan was appointed as an independent non-executive Director in 2015, and has served the Company for more than nine years. Since she was appointed, Ms. Kan has met the independence requirements as set out in Rule 3.13 of the Listing Rules and provided annual confirmations of independence to the Company pursuant to the same provision. During her years of service with the Company as an independent non-executive Director, Ms. Kan has contributed by exercising independent judgment, providing balanced and objective views on Company affairs, and supporting the Board with her comprehensive knowledge of the Group’s operations and businesses.

Having considered the requirements and obligations of independent non-executive Directors, including the independence criteria as set out in Rule 3.13 of the Listing Rules, the Nomination Committee is satisfied that Ms. Kan continues to be independent. The Board, having considered the relevant assessment and recommendation by the Nomination Committee, considers that Ms. Kan remains independent notwithstanding the length of her service, and is able to continue to fulfil her role effectively by contributing to the diversity of the Board with her valuable professional knowledge and extensive experience in the entertainment industry. As at the Latest Practicable Date, the Directors, to the best of their knowledge, are not aware of any matters or events that affect Ms. Kan’s independence. A separate resolution will therefore be proposed at the Annual General Meeting to approve the re-election of Ms. Kan as an independent non-executive Director.

The Nomination Committee has recommended to the Board the re-election of all the retiring Directors who are due to retire at the Annual General Meeting. Biographical details of the Directors proposed to be re-elected at the Annual General Meeting are set out in Appendix I to this circular.

3. PROPOSED RE-APPOINTMENT OF AUDITOR AND TO AUTHORISE THE BOARD TO FIX ITS REMUNERATION

An ordinary resolution will be proposed at the Annual General Meeting to re-appoint PricewaterhouseCoopers as the Auditor of the Company to hold office until the conclusion of the next annual general meeting of the Company and to authorise the Board to fix its remuneration.

The estimated audit fee payable to PricewaterhouseCoopers for its annual audit and audit-related services to the Group for the financial year ending December 31, 2026 is expected to be in the range of approximately RMB2,542,000 to RMB2,602,000. The estimated audit fee is inclusive of out-of-pocket expenses but excludes tax, which will be charged separately. The estimated audit fee has been determined after due consideration and arm's length discussions between the Company and PricewaterhouseCoopers, taking into account, among other things, the historical audit fee agreed by the Company and PricewaterhouseCoopers, the size, nature and complexity of the Group, the expected scope of the audit, the audit timetable, and the level and mix of professional staff and other resources expected to be deployed. The estimated audit fee is based on the assumption that there will be no material change in the Group's operations, business plan, accounting policies, audit scope or applicable regulatory requirements during the financial year ending December 31, 2026 and represents a fair and reasonable estimate based on the facts and circumstances known at the relevant time.

4. PROPOSED GRANTING OF GENERAL MANDATE TO BUY BACK SHARES

At the annual general meeting of the Company held on 12 June 2025, a general mandate was granted to the Directors to buy back Shares. Such mandate will lapse at the conclusion of the Annual General Meeting. In order to give the Company the flexibility to buy back Shares if and when appropriate, an ordinary resolution will be proposed at the Annual General Meeting to approve the granting of the Share Buy-back Mandate to the Directors to buy back Shares on the Stock Exchange of not exceeding 10% of the total number of issued Shares (excluding Treasury Shares, if any) as at the date of passing of the proposed ordinary resolution contained in item 4 of the notice of the Annual General Meeting as set out on pages 16 to 19 of this circular (i.e. a total of 33,988,722 Shares on the basis that no further Shares are issued or bought back between the Latest Practicable Date and the Annual General Meeting).

The Directors will evaluate the trading price of the Shares from time to time and may exercise the Share Buy-back Mandate when they consider that the Shares are trading at a level which does not reflect the underlying value of the Company.

An explanatory statement required by the Listing Rules to provide the Shareholders with requisite information reasonably necessary for them to make an informed decision on whether to vote for or against the granting of the Share Buy-back Mandate is set out in Appendix II to this circular.

5. PROPOSED GRANTING OF GENERAL MANDATE TO ISSUE SHARES

At the annual general meeting of the Company held on 12 June 2025, a general mandate was granted to the Directors to issue Shares. Such mandate will lapse at the conclusion of the Annual General Meeting. In order to give the Company the flexibility to issue Shares if and when appropriate, an ordinary resolution will be proposed at the Annual General Meeting to approve the granting of the Issuance Mandate to the Directors to allot, issue and deal with additional Shares of not exceeding 20% of the total number of issued Shares (excluding Treasury Shares, if any) as at the date of passing of the proposed ordinary resolution contained

in item 5 of the notice of the Annual General Meeting as set out on pages 16 to 19 of this circular (i.e. a total of 67,977,444 Shares on the basis that no further Shares are issued or bought back between the Latest Practicable Date and the Annual General Meeting). An ordinary resolution to extend the Issuance Mandate by adding the number of Shares bought back by the Company pursuant to the Share Buy-back Mandate will also be proposed at the Annual General Meeting.

The Directors wish to state that they have no immediate plan to issue any new Shares pursuant to the Issuance Mandate.

6. ANNUAL GENERAL MEETING AND PROXY ARRANGEMENT

The notice of the Annual General Meeting is set out on pages 16 to 19 of this circular.

Pursuant to the Listing Rules and the Articles of Association, any vote of Shareholders at a general meeting must be taken by poll except where the chairman, in good faith, decides to allow a resolution relating to a procedural or administrative matter to be voted on by a show of hands. An announcement on the poll results will be published by the Company after the Annual General Meeting in the manner prescribed under the Listing Rules.

A form of proxy for use at the Annual General Meeting is enclosed with this circular and such form of proxy is also published on the websites of Hong Kong Exchanges and Clearing Limited (<http://www.hkexnews.hk>) and the Company (<http://www.imax.cn>). To be valid, the form of proxy must be completed and signed in accordance with the instructions printed thereon and deposited, together with the power of attorney or other authority (if any) under which it is signed or a notarially certified copy of that power of attorney or authority, at the Company's Hong Kong share registrar, Computershare Hong Kong Investor Services Limited, at 17M Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong as soon as possible but in any event not less than 48 hours before the time appointed for the Annual General Meeting (i.e. not later than 7:00 a.m. on 9 June 2026 (Hong Kong time)) or the adjourned meeting (as the case may be). Completion and delivery of the form of proxy will not preclude you from attending and voting at the Annual General Meeting if you so wish.

7. RECOMMENDATION

The Directors consider that the proposed re-election of retiring Directors, the proposed re-appointment of Auditor and authorisation of the Board to fix its remuneration, and the proposed granting of the Share Buy-back Mandate and the Issuance Mandate are in the best interests of the Company and the Shareholders as a whole. Accordingly, the Directors recommend the Shareholders to vote in favour of the relevant resolutions to be proposed at the Annual General Meeting.

The following are details of the Directors who will retire and being eligible, offer themselves for re-election at the Annual General Meeting.

(1) Mr. Daniel Manwaring

Mr. Daniel Wade Manwaring, aged 41, has been appointed as the Chief Executive Officer of the Company since 9 January 2023 and has been appointed as the executive Director with effect from 27 February 2024. He is responsible for the day-to-day management of the business and operations of the Company. Furthermore, Mr. Manwaring holds directorship or legal representative positions in certain subsidiaries of the Company. Prior to joining the Company, Mr. Manwaring spent nearly 10 years with Creative Artists Agency (“CAA”), a well-known talent agency, in various roles, including as Head of Media Finance (Asia) from January 2020 to December 2022, Head of Motion Pictures China from January 2018 to December 2020, and as an agent from January 2013 to December 2018. Mr. Manwaring was the founder of AF Design, an auto parts business for luxury cars which was closed in January 2013, from October 2011 to December 2012. Mr. Manwaring was also a Senior Financial Analyst of China Hydroelectric Corporation (NYSE: CHC) from October 2008 to October 2011 and a Financial Analyst of Friedland Capital Inc. from May 2007 to October 2008. Mr. Manwaring graduated from the University of Florida, the United States, with a Bachelor of Science in Finance and a Bachelor of Arts in Chinese Language and Culture, in May 2008. Mr. Manwaring has been based in China since 2006 and is fluent in Mandarin. He also took Chinese courses at Tsinghua University in China.

Save as disclosed herein, Mr. Manwaring has not held other directorships in the last three years in public companies the securities of which are listed on any securities market in Hong Kong or overseas and does not have any relationship with any Director, senior management and substantial Shareholder of the Company.

Mr. Manwaring has entered into a letter of appointment with the Company in respect of his appointment as an executive Director with a term of approximately twenty-seven months commencing from 27 February 2024 until the conclusion of the annual general meeting of the Company approving the annual report for the year ended 31 December 2025, and subject to retirement by rotation and reelection at the annual general meeting of the Company in accordance with the Articles of Association. If Mr. Manwaring is re-elected, the Company will enter into a new letter of appointment with Mr. Manwaring, upon which Mr. Manwaring will be appointed for a term of approximately 3 years commencing from 11 June 2026 until the conclusion of the annual general meeting of the Company approving the annual report for the year ended 31 December 2028, subject to retirement by rotation and re-election at the annual general meeting of the Company in accordance with the Articles of Association.

Mr. Manwaring is entitled to a base salary of USD636,540 per annum, a target bonus equal to 45% of his annual base salary at the discretion of the Company, an annual equity award under share schemes of IMAX Corporation and the Company with an aggregate grant date monetary value of USD750,000, USD700,000 and USD700,000 for each of the years 2026, 2027 and 2028, respectively, and an annual allowance of USD244,200. Mr. Manwaring is not entitled to any further remuneration for his role as an executive Director. The above emoluments of Mr. Manwaring have been determined with reference to prevailing market conditions, based on the responsibilities taken up by Mr. Manwaring and the professional expertise that he possesses.

As at the Latest Practicable Date, Mr. Manwaring is interested in 411,990 Shares, 178,457 RSUs and 356,914 PSUs (including additional 178,457 PSUs which might be granted to Mr. Manwaring when certain performance vesting criteria is reached) of the Company; and he is interested in 12,363 common shares, 21,816 RSUs and 64,881 PSUs (including potential additional 26,722 PSUs) of IMAX Corporation, the controlling Shareholder of the Company.

Save for the information disclosed above, there is no information which is disclosable nor is Mr. Manwaring involved in any of the matters required to be disclosed pursuant to any of the requirements under Rules 13.51(2)(h) to (v) of the Listing Rules and there are no other matters concerning Mr. Manwaring that need to be brought to the attention of the Shareholders.

(2) Ms. Yue-Sai Kan

Ms. Yue-Sai Kan, aged 78, has been an independent Director since 25 August 2014 and was appointed as an independent non-executive Director on 27 May 2015. She is responsible for giving independent strategic advice and guidance on the business and operations of the Group. Ms. Kan is an Emmy-winning television host and producer with extensive experience in the entertainment industry. In 1972, she established Yue-Sai Kan Productions and created her first major U.S. television production, a weekly series called “Looking East.” In 1986, she produced and hosted the television series “One World” on China’s national television network, CCTV. Ms. Kan has produced a number of documentaries, including “China Walls and Bridges”, which earned her an Emmy, as well as “Journey through a Changing China” and the series “Mini Dragons” “Doing Business in Asia,” and “Seeking Miss China,” among others. Ms. Kan created the cosmetics company and brand “Yue-Sai” in 1992, which was acquired by L’Oréal in 2004. She is now the Honorary Vice Chairman of L’Oréal China. She launched the House of Yue-Sai lifestyle stores in 2007 to cater to China’s growing middle class. She is also an author of nine best-selling books. She is also the National Director of Miss Universe China and produces its annual pageant as a major charity event in China. Ms. Kan graduated from the Brigham Young University in Hawaii with a Bachelor of Arts in May 1969. Ms. Kan has served as the International Ambassador of the Shanghai International Film Festival since 2006.

Save as disclosed herein, Ms. Kan has not held other directorships in the last three years in public companies the securities of which are listed on any securities market in Hong Kong or overseas and does not have any relationship with any Director, senior management and substantial Shareholder of the Company.

Ms. Kan has entered into a letter of appointment with the Company in respect of her appointment as an independent non-executive Director with a term of approximately three years commencing from 7 June 2024 until the conclusion of the annual general meeting of the Company approving the annual report for the year ending 31 December 2026, and subject to retirement by rotation and re-election at the annual general meeting of the Company in accordance with the Articles of Association.

Ms. Kan is entitled to receive an annual fee of US\$50,000 and an additional fee of US\$10,000 per annum for membership (as applicable) of each of the board committees of the Company and a further fee of US\$5,000 per annum for being the chairman of any one of those board committees. She is also entitled to receive a discretionary award of RSUs in respect of Shares having a value at grant of up to US\$100,000 per annum. The above emoluments of Ms. Kan have been determined with reference to her role and duties, performance and responsibilities as well as the prevailing market conditions.

As at the Latest Practicable Date, Ms. Kan had interest of 622,551 Shares in the Company within the meaning of Part XV of the SFO.

Ms. Kan has confirmed that (a) she is independent having regard to each of the factors referred to in Rule 3.13 of the Listing Rules; and (b) there are no relationships or circumstances that would interfere with her ability to act as an Independent Non-executive Director.

Save for the information disclosed above, there is no information which is disclosable nor is Ms. Kan involved in any of the matters required to be disclosed pursuant to any of the requirements under Rule 13.51(2)(h) to (v) of the Listing Rules and there are no other matters concerning Ms. Kan that need to be brought to the attention of the Shareholders.

(3) Ms. Janet Yang

Ms. Janet Yang, aged 69, has been appointed as an independent non-executive Director and a member of the audit committee of the Company with effect from 20 February 2024. Ms. Yang is a Founder and President of Janet Yang Productions since 1998. She is a film producer and the former President of the Academy of Motion Pictures Arts and Sciences which ends in July 2025. She also serves as a member of the Committee of 100, a leadership organization of prominent Chinese-Americans. Ms. Yang graduated from Brown University with a bachelor's degree in International Relations in June 1978 and graduated from Columbia University with an MBA in Business Administration in June 1984. She was also a visiting student at Harvard University in East Asian Studies from 1976 to 1978.

Save as disclosed herein, Ms. Yang has not held other directorships in the last three years in public companies the securities of which are listed on any securities market in Hong Kong or overseas and does not have any relationship with any Director, senior management and substantial Shareholder of the Company.

Ms. Yang has entered into a letter of appointment with the Company in respect of her appointment as an Independent Non-executive Director with a term of approximately twenty-eight months commencing from 20 February 2024 until the conclusion of the annual general meeting of the Company approving the annual report for the year ended 31 December 2025, and subject to retirement by rotation and re-election at the annual general meeting of the Company in accordance with the Articles of Association. If Ms. Yang is re-elected, the Company will enter into a new letter of appointment with Ms. Yang, upon which Ms. Yang will be appointed for a term of approximately 3 years commencing from 11 June 2026 until the conclusion of the annual general meeting of the Company approving the annual report for the year ended 31 December 2028, subject to retirement by rotation and re-election at the annual general meeting of the Company in accordance with the Articles of Association.

Ms. Yang is entitled to receive an annual fee of US\$50,000 and an additional fee of US\$10,000 per annum for membership (as applicable) of each of the board committees of the Company and a further fee of US\$5,000 per annum for being the chairman of any one of those board committees. She is also entitled to receive a discretionary award of RSUs in respect of Shares having a value at grant of up to US\$100,000 per annum. The above emoluments of Ms. Yang have been determined with reference to her role and duties, performance and responsibilities as well as the prevailing market conditions.

As at the Latest Practicable Date, Ms. Yang had interest of 187,443 Shares in the Company within the meaning of Part XV of the SFO.

Ms. Yang has confirmed that (a) she is independent having regard to each of the factors referred to in Rule 3.13 of the Listing Rules; and (b) there are no relationships or circumstances that would interfere with her ability to act as an Independent Non-executive Director.

Save for the information disclosed above, there is no information which is disclosable nor is Ms. Yang involved in any of the matters required to be disclosed pursuant to any of the requirements under Rule 13.51(2)(h) to (v) of the Listing Rules and there are no other matters concerning Ms. Yang that need to be brought to the attention of the Shareholders.

The following is an explanatory statement required by the Listing Rules to provide the Shareholders with requisite information reasonably necessary for them to make an informed decision on whether to vote for or against the ordinary resolution to be proposed at the Annual General Meeting in relation to the granting of the Share Buy-back Mandate.

1. SHARE CAPITAL

As at the Latest Practicable Date, the issued share capital of the Company comprised 339,887,221 Shares.

Subject to the passing of the ordinary resolution set out in item 4 of the notice of the Annual General Meeting in respect of the granting of the Share Buy-back Mandate and on the basis that no further Shares are issued or bought back between the period from the Latest Practicable Date and the Annual General Meeting, i.e. being 339,887,221 Shares, the Directors would be authorized under the Share Buy-back Mandate to buy back, during the period in which the Share Buy-back Mandate remains in force, a total of 33,988,722 Shares, representing 10% of the total number of Shares in issue (excluding Treasury Shares, if any) as at the date of the Annual General Meeting.

2. REASONS FOR SHARE BUY-BACK

The Directors believe that the granting of the Share Buy-back Mandate is in the best interests of the Company and the Shareholders as a whole.

Shares buy-back may, depending on the market conditions and funding arrangements at the time, lead to an enhancement of the net asset value per Share and/or earnings per Share and will only be made when the Directors believe that such a buy-back will benefit the Company and the Shareholders. The Directors are seeking the grant of the Share Buy-back Mandate to give the Company the flexibility to do so if and when appropriate. The number of Shares to be bought back on any occasion and the price and other terms upon which the same are bought back will be decided by the Directors at the relevant time, having regard to the circumstances then pertaining.

3. FUNDING OF BUY-BACK

The Company may only apply funds legally available for share buy-back in accordance with its Memorandum and Articles of Association, the laws of the Cayman Islands and/or any other applicable laws, as the case may be.

A listed company may not buy back its own securities on the Stock Exchange for a consideration other than cash or for settlement otherwise than in accordance with the trading rules of the Stock Exchange. Any purchase by the Company may be made out of the profits of the Company or out of a fresh issue of Shares made for the purpose of the purchase or, subject to the Cayman Companies Law, out of capital and, in the case of any premium payable on the purchase, out of the profits of the Company or from sums standing to the credit of the share premium account of the Company or, subject to the Cayman Companies Law, out of capital.

It is currently envisaged that the funds required for any repurchase would be derived from the profits of the Company available for distribution.

4. IMPACT OF SHARE BUY-BACK

There might be a material adverse impact on the working capital or gearing position of the Company (as compared with the position disclosed in the audited accounts contained in the annual report of the Company for the year ended 31 December 2025) in the event that the Share Buy-back Mandate was to be carried out in full at any time during the proposed buy-back period. However, the Directors do not intend to exercise the Share Buy-back Mandate to such extent as would, in the circumstances, have a material adverse effect on the working capital requirements of the Company or the gearing levels which, in the opinion of the Directors, are from time to time appropriate for the Company.

6. EXERCISE OF SHARE BUY-BACK MANDATE AND DISCLOSURE OF INTERESTS

To the best of their knowledge and having made all reasonable enquiries, none of the Directors nor any of their respective close associates (as defined in the Listing Rules) have any present intention to sell any Shares to the Company in the event that the granting of the Share Buy-back Mandate is approved by the Shareholders.

The Company has not been notified by any core connected persons (as defined in the Listing Rules) of the Company that they have a present intention to sell any Shares to the Company, or that they have undertaken not to sell any Shares held by them to the Company, in the event that the granting of the Share Buy-back Mandate is approved by the Shareholders.

The Company intends to cancel the Shares repurchased under the Share Buy-back Mandate.

The Directors will exercise the power of the Company to buy back Shares pursuant to the Share Buy-back Mandate in accordance with the Listing Rules and the applicable laws of the Cayman Islands. In addition, the Company has confirmed that neither the Explanatory Statement nor the proposed share repurchase has any unusual features.

7. TAKEOVERS CODE

If, as a result of a buy-back of Shares pursuant to the Share Buy-back Mandate, a Shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition of voting rights for the purposes of the Takeovers Code. Accordingly, a Shareholder or a group of Shareholders acting in concert (within the meaning of the Takeovers Code), depending on the level of increase in the Shareholder's interest, could obtain or consolidate control of the Company and thereby become obliged to make a mandatory offer in accordance with Rule 26 of the Takeovers Code.

To the best knowledge of the Company, as at the Latest Practicable Date, IMAX Corporation, the controlling Shareholder of the Company (as defined in the Listing Rules) was interested in 243,262,600 Shares, representing approximately 71.57% of the total issued share capital of the Company. In the event that the Directors exercise the proposed Share Buy-back Mandate in full, the aggregate shareholding of IMAX Corporation would be increased to approximately 79.52% of the issued share capital of the Company and the number of Shares held by the public would fall below 25% of the total issued share capital of the Company then in issue.

The Directors are not aware of any consequences which may give rise to an obligation to make a mandatory offer under Rule 26 of the Takeovers Code. The Directors do not propose to exercise the Share Buy-back Mandate to such an extent as would, in the circumstances, give rise to an obligation to make a mandatory offer in accordance with Rule 26 of the Takeovers Code and/or result in the aggregate number of Shares held by the public Shareholders falling below the prescribed minimum percentage required by the Stock Exchange.

8. BUY-BACK OF SHARES MADE BY THE COMPANY

No buy-back of Shares has been made by the Company (whether on the Stock Exchange or otherwise) in the six months immediately preceding the Latest Practicable Date.
